That is our juridical identity. Court decisions on the Saramaka people v. Suriname (2007-2012), and Garifuna Community Punta Piedra v Honduras have established our right to land, authority and resources as Afro descendants. Then there is the issue of indigenous status as many of these Afro descendants ancestors came here before these European colonizers as such are indigenous to the land. Again giving them rights to the land, authority and resources. This must be addressed as part of the acknowledgement and truth that must come forward about our history and our identity and our rights to our land and resources, stolen by these invaders /colonizers.
