



FY24 Appropriations Community Project Funding – Accounts Available for Requests

Community Project Funding allows a specific organization to receive federal funds under an existing program without having to compete. The organization must comply with all requirements of the existing program. Community Project Funding is only available for certain programs. The accounts available for Community Project Funding are organized by the 12 Appropriations Subcommittees with responsibility for that program. Below is a list of accounts for FY24 for which an organization can make a request for Community Project Funding. Note: Members are allowed to submit up to 15 projects from their districts.
